### The Seller Agrees:

The puppy is in good health at the time of sale. The buyer will have 3 business days (72 hours) including Saturday in which to have the puppy examined by his or her own licensed veterinarian. If your veterinarian determines the puppy to be ill, or for any reason this puppy is unacceptable, Buyer may return the puppy for a full refund, provided it is in the same condition as at the time purchase. If the puppy is returned due to illness, a letter from your veterinarian is required. This includes death or illness from any health condition deemed present prior to removal from Seller's premises. Buyer shall assume any expenses, including transportation expenses associated with returning this puppy to the Seller along with any veterinary costs after departure from the Breeder.

The puppy is guaranteed to be a functional, healthy companion dog. Every reasonable precaution has been taken to prevent this puppy from acquiring heredity hip dysplasia, elbow dysplasia, cataracts, or Subaortic Stenosis. Due to the unknown hereditary and environment causes of such defects, no guarantees will be given against them. Both Buyer and Seller are aware that the dogs are actual living beings, and like any living thing – they are susceptible to sickness and disease and that is a normal part of owning a pet. Unless specifically covered in this agreement, this is to be considered a normal part of pet ownership with no liability on the part of the seller.

### The Buyer Agrees:

That this puppy will be indoors and given adequate and proper shelter and exercise and be housed securely. This dog shall not be neglected, allowed to roam free, left outside unattended, or mistreated in any manner. This puppy/dog shall not be restrained routinely by chaining to a stationary object. (Tree, post etc.)

That the puppy shall receive proper veterinary care throughout its lifetime, receiving the appropriate vaccinations and being placed on a flea and tick preventative as well as a heartworm preventative.

The puppy shall receive proper nutrition and care shall be taken to maintain its proper weight throughout all stages of life.

At Wyoming Golden we are doing everything in our power to produce healthy puppies from conception. The efforts put forth by us should not stop when that puppy leaves us to join your family. We wholeheartedly believe in feeding the highest quality, super premium dog food available. **We have personally found Life's Abundance brand dog food to be the best, well-balanced dog food on the market. This food is sold through breeders and pet professionals. It is not sold in pet stores or vet offices. You order your products online and they are delivered right to your door.**

It is our testimony that their food is formulated to be the best for our breed. This company has never had a recall on any of their products and they do not use chemicals in their dog food – as a result they are finding that dogs being fed this food are living longer lives.

PLEASE KNOW - **YOUR PUPPY/DOG SHOULD STAY ON THE NUVET PLUS UNTIL APPROXIMATLEY 5 YEARS OF AGE. AT 5 YEARS OF AGE AND ON THEY SHOULD BE SWITCHED TO THE NUJOINT SUPPLEMENT TO KEEP AGING BONE LUBRICATED AND STRONG.**

**This puppy is being sold for the purpose of being a companion animal** and is being sold on a Limited Registration for the purpose of being a companion animal and, therefore, the Buyer agrees that it will **not** be bred. Buyer **AGREES TO SPAY FEMALES AFTER THEIR FIRST HEAT CYCLE AND AFTER THEY ARE ONE YEAR OF AGE. THE BUYER AGREES TO NEUTER THEIR MALE AT 18 MONTHS OF AGE. KEEP IN MIND – FOLLOWING THESE INSTRUCTIONS CAN HURDLE OVER SOME OF THE CANCERS GOLDEN RETRIEVERS ARE KNOWN TO GET.**

The Buyer will furnish to Seller a statement from Buyer's veterinarian stating he/she has been spayed/neutered when the times comes to spay/neuter said dog. The Buyer shall incur all expenses.

**\*\*If the Seller discovers this dog is being used for breeding purposes to outside parties, the Seller will be required to pay the Seller \$18,000.00 for each offense in addition to all legal expenses.**

That the Buyer will notify the Seller first if for **any reason** the Buyer no longer wants or is able to care for the puppy. The Seller shall have first right of refusal and will take the puppy back. This is in effect for the lifetime of the dog. Buyer shall assume any expenses associated with returning this puppy to the Seller for ANY reason.

**If the Buyer sells this puppy/dog without consulting the Seller and without spaying/neutering said dog prior to placement, the Buyer will be required to pay the Seller \$9000.00.**

That the Buyer will notify the Seller of any changes of address and will maintain contact with Seller throughout the lifetime of this dog.

That the Buyer agrees to notify Seller of any titles completed as determined by the AKC.

That Seller suggests the dog to attend at least ten (10) weeks of formal obedience training at the school of the Buyer's choice.

That this dog shall not be used for purposes of vivisection and not be sold by or to a wholesale establishment, chain store, pet store or "puppy mill" or foreign country.

**NO GUARANTESS OR WARRANTIES, EXPRESS OR IMPLIED, ARE GIVEN BY DENYCE AND FRAN MCLAUGHLIN AS SELLER, AND ALL DOGS ARE SOLD AND DELIVERED IN AN "AS IS" CONDITION, EXCEPT AS EXPRESSLY AND SPECIFICALLY SET FORTH HEREIN.**
